# **NOTICE TO PLAYERS**



(This notice supplements the Local Rules and Terms of Competition for NWAGA Events)

### Abnormal Course Conditions:

Decorative Flower and Plant Beds are deemed to be ground under repair even though not so defined by white lines.

<u>Turf Nursery located right of hole #18</u> is ground under repair from which play is prohibited. If interference exists, relief must be taken. Such nursery is not defined, but it constitutes all of the area cut at approximately putting green height or less.

#### Flag sticks:

# Rule 13.2b is modified in this way - attending and removal of the flag stick is prohibited. Player's are subject to penalty NWAGA code of conduct for a flag stick that is attended or removed.

#### Bunkers: (Lift, Clean & Place)

When a player's ball lies in a bunker, the player may take free relief once by placing the ball or another ball in and playing it from this relief area;

- i. Reference point spot of the original ball
- ii. Size of relief area measured from reference point

iii. One club length from the reference point, with these limitations

- 1. Must not be nearer to the hole from the reference point
- 2. Must be in the same bunker

#### **Drop Zones:**

If a ball is in the following penalty areas, including when it is known or virtually certain that a ball that has not been found came to rest in the penalty area, the player has these relief options, each for one penalty stroke: 1) Take relief under Rule 17.1; or 2) As an extra option, drop the original ball or another ball in the dropping zone marked "DZ" in the location below. The dropping zone is a relief area under Rule 14.3.

Hole #1 Yellow Penalty Area - Drop Zone located near the yellow penalty area.

Hole #5 Yellow Penalty Area - Drop Zone located right of the cart path near the green.

Hole #8 Red Penalty Area - Drop Zone located in the rough.

Hole #10 Yellow Penalty Area - Drop Zone located near the yellow penalty area short right of the putting green.

Hole #13 Yellow Penalty Area - Drop Zone located in the fairway.

#### Loose Impediments:

Wood chips, pine straw and mulch are loose impediments.

#### **Obstructions:**

Birdhouses and their posts are immovable obstructions.

Flower and plant beds enclosed by cart paths or adjacent to immovable obstructions are deemed to be part of the obstruction.

Immovable obstructions adjacent to each other are to be treated as a single obstruction.

Staked Trees (including tree wells associated with staked trees) are deemed to be immovable obstructions.

#### **Out of Bounds:**

Out of Bounds is defined by the perimeter fence, white dots and white lines in addition to white stakes.

#### Deciding Ties:

If there are ties for 1st or 2nd place in a flight, the ties will be broken as follows:

- i. Result of head to head match.
- ii. Highest point total on day 1 (race 1, 2, and 3 combined)
- iii. Highest point total on day 2 (race 4 and 5 combined)
- iv. Most points in race 1
- v. Most points in race 2
- vi. Most points in race 3
- vii. Most points in race 4
- viii. Most points in race 5
- ix. If still tied, the winner will be decided by lot

## Scoring:

One player per group must enter scores for all members using the USGA TM mobile app. GGID's for each group will be located on the scorecard.

## Teeing Ground:

The blue NWAGA Tee-Markers define the teeing ground for the competition.
