**NOTICE TO PLAYERS**

(This notice supplements the Local Rules and Conditions of Competition for NWAGA Championships & Events) **For any ruling assistance, please call (402) 305-8100.**

**Format:**

A team consists of two players. On each hole, a player and his/her partner drive from the teeing ground. On the second stroke, player A will play player B's ball while player B will play player A's ball. Prior to the third stroke, the partners must make a choice which ball they will play. There will be only one ball played by each team after the second stroke. Penalty strokes do not affect order of play. If the players choose the ball played on B's second stroke, player A will play the third stroke and they will play alternate strokes until the ball is holed. At no time will a player strike the same ball twice in succession.

**Abnormal Ground Conditions:**

Flower and Plant Beds and their Rock Borders are deemed to be ground under repair even though not so defined by white lines.

Area left of #4 green has been reseeded and is deemed as ground under repair and marked with white paint.

Area left of #5 fairway has been reseeded and is deemed as ground under repair and marked with white paint.

Area in front of #7 green has been reseeded and is deemed as ground under repair and marked with white paint.

Temporary Water in front of #10 green. Players are entitled to free relief under Rule 16.1b - Free Relief from an abnormal course condition in the general area.

Area back left of #17 near the cart path has burrowing animal holes present. Players are entitled to free relief under Rule 16.1b - Free Relief from an abnormal course condition in the general area.

**Temporary Water:**

Any temporary accumulation of water on the surface of the ground that is not in a **penalty area**, and can be seen before you take a stance (without pressing down excessively with your feet). Players are entitled to free relief under Rule 16.1b - Free Relief from an abnormal course condition in the general area.

**Deciding Ties:**

All ties will be broken by the USGA scorecard playoff method.

**Integral Part of the Course:**

The Rail Road Tie Walls within the Lateral Water Hazards Between Holes 13 & 16 are deemed to be an integral part of the course, therefore, no relief without penalty.

**Obstructions:**

Artificially Surfaced Roads and Paths include those surfaced with crushed brick, gravel or asphalt.

Prepared Flower Beds adjacent to Immovable Obstructions have the same status and are considered one obstruction.

Yardage Posts are deemed to be Movable Obstructions.

**Out of Bounds:**

Out of Bounds is defined by the perimeter fence and white lines in addition to white stakes. When defined by white lines, the line itself is out of bounds.

**Scoring Area:**

Scoring Area – A scorecard is deemed to be returned when the player has left the scoring area.

**Teeing Ground:**

Blue NWAGA tee-markers define the teeing ground.

**Wrong Putting Green:**

Practice Putting Greens are deemed to be wrong putting greens.
